TRIALS TYRES ONLY ALL CLASSES. WORKING LIGHTS ON TRAIL BIKES.

MACHINES ELIGIBILITY: Class 3 (pre-Villiers 9E & Bantam 123cc 3 speed prior to 30/12/57.

All Classes except 9 must be of **British** manufacture and have been readily available for sale to the general public before the eligibility date of the class. Classes concerned must be fitted with **British** front forks, motor/gearbox, main frame loop, Hubs. **Carburettor** except Class 9 should be of British manufacture up to Amal MK 1. No Reed Valves. Replica Frames will be accepted providing they are 90% identical to the original/readily available to the public. Any machine that does not comply will be entered in the special class. Trail bikes must have working lights and Trials Tyres. Riders are responsible for ensuring that their machine complies with Road Traffic Act and ACU requirements. Clutch and brake levers must end with a 3/4 inch diameter ball.

START/FINISH: At the Bear of Rodborough Hotel, Rodborough Common, Gloucestershire.

The first rider will be flagged off at **9.30am** with the other riders following in numerical order at one minute intervals. Riders will be advised of there time and riding number after the closing date.

ROUTE: Details of the location of all the sections will be issued prior to the event. At all times, riders must show respect to walkers, horse riders, etc and close all gates after they have passed through. Failure to do so will result in exclusion.

INSURANCE: All entrants will be insured against personal accident risks, the premium for such insurance being included in the entry fee. All riders are advised to check that their certificate of motor insurance covers them whilst competing in this type of event on public roads. Additional RTA Day Insurance is available at the Start for £

SCORING: Sections will be scored using the 0-1-2-3-5 system. No Stopping. Failure is deemed to have occurred when the machine ceases forward motion. Sidecar Drivers standing in the Chair will also be marked as a 5 Limit Knee on Saddle.

RESULTS: Results will be forwarded to all entrants as soon as possible after the event.
